By giving an order to **GPT**, Dr. Ekkehard Hübschmann, the client acknowledges and accepts the following:

1. The results of the research are provided by **GPT**, Dr. Ekkehard Hübschmann, in digital files.
2. The orders are legally binding arrangements. Place of jurisdiction is Gefrees, Bayreuth, Germany.
3. As soon as the provided digital files are come into the possession of the client—either via download on his computer or by handing over or by consignment on a data carrier—the files are considered as delivered and the agreement as fulfilled by **GPT**, Dr. Ekkehard Hübschmann. After delivery, the customer has no right of return and no right to a refund of amounts paid. In case payment after delivering was agreed, the client has no right of refusal of payment as soon as he received the files provided.
4. **GPT** will hold confidential any information provided by the client that is not already a matter of public record or public knowledge. **GPT** will treat with discretion, even if they are already matters of public record, issues that concern living persons, their parents, or immediate families. **GPT** will not hand over data and information received from the client to a third party without the client's consent.
5. **GPT**, Dr. Ekkehard Hübschmann, retains the right to make further use of the results of work done at the client's request, including publication in articles or books and lectures. The client's sponsorship of the research is only acknowledged if the client wishes it. However, **GPT** will not accept fees to provide these results to other interested persons but will, with the client's consent, refer them to the client for the information and allow the client to determine the terms under which the client may decide to share it.
6. The client agrees that if the client distributes to others or publish any information taken from **GPT**'s report, including the findings and conclusions, the client will report them accurately, will include any qualifiers (for example, the words *probable* or *possible*, when accompanying a conclusion), and the client will credit the report of **GPT**, Dr. Ekkehard Hübschmann, as the source. **GPT** retains the

copyright to the report and the manner in which GPT have expressed the information in it. The client may make a limited number of personal copies as a “fair use” of the copyrighted report, but the client agrees that he/she will not otherwise publish or make multiple copies of the report without the written permission of GPT, Dr. Ekkehard Hübschmann. The client may give copies of his personal ones to close relatives or close friends but not to distant relatives or to not-related people in order to give them information relevant for their genealogy or family history.
